- If an accident occurs (a) it must be reported immediately to the Company, (b) the details of all persons involved and any witness(es) and the police should be obtained and a sketch plan should be made. I hereby acknowledge receipt of the above car in good condition and including the accessories for the vehicle of which I accept full responsibility and for which I shall make full payment if found missing on return ie: Spare Wheel, Brace and Jack.
- All vehicles are sent for refuelling upon return regardless of the fuel gauge reflecting a full tank. In the event where the vehicle requires more than 1L to be filled a refuelling fee of R300, is applicable.
- This agreement is subject to the signing and acceptance of the Veloce Manual Card Authorisation.
- The condition of the vehicle is recorded as per time stamped electronic photographic recordings of the interior, exterior, rims and wheel condition any damage to the vehicle will be treated as per Veloce's Terms & Conditions.
